I refer to your email of 16 March 2023 requesting information about aircraft operated by the New Zealand Defence Force (NZDF).

I require the list of all aircraft by brand, model and registration number that has received funding from your department in the last 24 months. I require the total fuel budget expended for each aircraft in litres and the dollar amount.

Your request has been considered under the Official Information Act 1982 (OIA). A summary of the brands and models of aircraft operated by the Royal New Zealand Air Force is contained in the table below. The table also sets out fuel consumption and costs for aircraft from 27 March 2021 to 27 March 2023.
