I refer to your email of 16 June 2023 requesting, under the Official Information Act 1982 (OIA), the below information about the 16 June flight of a Royal New Zealand Air Force King Air, tail number NZ2350. I apologise for the delayed response.

Could I please make a request under the Official Information Act for copies of all communications, memos, texts, emails, photos and flight reports in relation to this flight. Please include a copy of the planned flight path.

I am also seeking communications following the incident, including any with the Defence Minister and media.

The King Air aircraft does not have a data management system; therefore, there is no flight path plotted for pilots to view where they have been tracking during the flight. As this was a routine training flight there are few details available regarding the flight path. The nature of the upper air portion of the flight involved manoeuvres and tracks between manoeuvres within the training area therefore there is no navigation plan or map produced. The aircraft was to fly to the M302 training area in the Taranaki Bight in order to perform a number of instrument approaches to Ohakea followed by circuits. Further details are provided by the Officer Commanding No 42 Squadron in his email of 16 June 2023, within Enclosure 3.

Relevant documentation is provided at Enclosures 1 and 2, being the pre-flight authorisation and the 42 Squadron flying programme respectively. Communications regarding the flight are at Enclosures 3, 4, 5, 6 and 7. Where indicated, personal information is withheld to protect privacy in accordance with section 9(2)(a) of the OIA. Signatures and contact details are withheld in accordance with section 9(2)(k) of the OIA to avoid the malicious or inappropriate use of staff information, such as phishing, scams or unsolicited advertising.

You have the right, under section 28(3) of the OIA, to ask an Ombudsman to review this response to your request. Information about how to make a complaint is available at www.ombudsman.parliament.nz or freephone 0800 802 602.

Please note that responses to official information requests are proactively released where possible. This response to your request will be published shortly on the NZDF website, with your personal information removed.

Good afternoon,

The sortie was a combined Instrument Rating Test and Day Handling Check for a B Category Pilot. KNG 50 entered the M302 training area and was instructed to hold outside 25 NM.

You will see from the aircraft's flight path that we departed Ohakea, turned right and flew straight to our training area. From there we conducted a stall for practice and as we were subsequently tracking to the North East the candidate conducted a steep turn to the left at 45 degrees AOB for a full 360 degrees which was reversed into a right hand steep turn at 45 degrees AOB for another 360 degrees.

From there we requested to vacate the area to conduct an instrument approach straight in on runway 09 at Ohakea. Prior to flying radar vectors the aircraft entered a left hand orbit to prepare the flight management and navigation system. Once ready the radar vectors commenced. The aircraft initially continued north east and was reversed around to the West to intercept the extended centreline to conduct the ILS approach from RWY 09.

It was not the intention of the crew, and certainly not mine as aircraft captain to draw any phallic symbol in the sky.

Regarding the OIA inquiry into the CAT Check/IRT conducted last Friday;

The aircraft CVR has a capacity of 2 hours so any audio data is likely no longer available. The aircraft was flown for approximately a further 1.2 hours following the upper air exercises and then it flew to Christchurch to participate in the Wigram Air Show for a total of 2.1. Furthermore it has been flying a CT this morning which would add at least a 0.7. As soon as I received this email I directed the aircraft to land to attempt to preserve whatever data we can.

Until we determine that this data is unrecoverable we will not fly the aircraft. I am unsure of the process of CVR data collection and recovery by the RNZAF, or whether this is required in this case. Can you please provide some additional guidance?

For your information I was the aircraft captain for this sortie, I don't know whether this would influence a decision as to who would be the most appropriate person to collate this data, or whether it should be done by 42 SQN internally. Nonetheless, 42 SQN will make whatever data is requested available to whomever is nominated.







Text messages between Air Component Commander and Chief of Air Force










Text messages between Chief of Defence Force and Chief Advisor Public Affairs on 16 June.
