I refer to your email of 13 May 2024 requesting, under the Official Information Act 1982 (OIA), the below information about a New Zealand Defence Force (NZDF) flight to the Chatham Islands in early May.

I apologise for delay in providing this response. The NZDF operated a flight to the Chatham Islands on 7 May 2024 at the request of the Department of Internal Affairs under Output 4.4 – Military assistance to Civil Authorities in Non-Emergency Situations. Information concerning Output 4.4 is publicly available in the Annual Report on the NZDF Website¹. The purpose of the flight was to transport attendees of the Chatham Islands Stakeholder's Forum and was a 2.5 hour direct flight from Wellington International Airport to Tuuta Airport by a C-130H Hercules aircraft. The short term operating rate² of an NZDF Hercules is \$8,330 per flying hour.

² This rate includes marginal personnel costs, fuel, airport charges and other associated costs in relation to the flight. Short-term tasking rates do not include workshop maintenance, personnel salaries, depreciation and capital charge.

There were 37 passengers on board the flight, and 11 NZDF personnel. The names of passengers on board the flight who are public officials are below, along with their agency. The job titles of the officials was not recorded by the NZDF. The names of the remaining passengers are withheld in accordance with section 9(2)(a) of the OIA, to protect their privacy.

The NZDF crew on board ranged in rank from Corporal to Flight Lieutenant and comprised of a Pilot, a Co-pilot, an Air Warfare Officer, a Flight Engineer, two Air Load Masters, two maintenance personnel, and two Air Load Team members. The current remuneration range for the ranks concerned is approximately \$88,000 to \$120,000.
