I refer to your email of 21 November 2024 requesting, under the Official Information Act 1982 (OIA), information relating to current usage and projected demand for NZDF to provide search and rescue helicopter support to other government agencies, over the last three years. I apologise for the delay in providing this response.

In accordance with Output 4 of the New Zealand Defence Force (NZDF) Output Plan, specialised capabilities for the provision of public services in emergency situations are made permanently available. This includes the availability of capabilities to assist the civil power conduct Search and Rescue (SAR) and recovery operations within New Zealand, New Zealand's Search and Rescue Region (SSR), and adjacent SSRs. SAR operations by night or day are an authorised activity for the NH90 helicopter. NZDF Outputs are contained in the NZDF Statement of Intent 2024¹.

NZDF NH90 aircraft accumulated 75.4 flying hours of SAR tasks under Output 4 during the last three years. This does not include hours flown in response to national/regional emergencies during the requested period as it would require a significant research and collation effort to generate the requested information (more than 130 missions were flown by NH90s in response to Cyclone Gabrielle). The impact of SAR flights and training for SAR flights on NZDF activities is minimal and has no significant impact on the provision of military output options in response to New Zealand Government requirements.

With respect to basing, the NH90 helicopters are operated by 3 Squadron of the Royal New Zealand Air Force (RNZAF), based at RNZAF Base Ohakea. Fuel requirements are provisioned for by the NZDF according to the requirements of each tasking. Communications regarding the logistics arrangements for the SAR missions that accounted for the 75.4 flying hours are enclosed. These are not provided in any particular order. Where indicated, names and contact details are withheld in accordance with section 9(2)(a) of the OIA to protect their privacy. Other information is withheld in accordance with section 6(a) of the OIA, as making this information available would prejudice the defence and security of New Zealand. Information provided in confidence to the NZDF is withheld in accordance with section 9(2)(ba)(i) of the OIA.
