I refer to your email of 17 October 2024 to the Ministry of Defence requesting information regarding HMNZS Lachlan. Your request was transferred to the New Zealand defence Force (NZDF) for response in accordance with the Official Information Act 1982 (OIA).

I am seeking information re HMNZS Lachlans mission to intercept radio activity on Mururoa 1973 prior to Canterbury and Otago sailing. I believe it was a secret mission called by Norman Kirk and query why the log was kept under lock and key for so many years. From what info I have acquired there are conflicting reports as to this log can you enlighten me on this point please.

HMNZS Lachlan did not go to Mururoa Atoll in 1973. The ship undertook activities in Samoa, Tokelau and the Cook Islands in June 1973, returning to dock at Devonport Naval Base on 7 July 1973. There is no reference in files to HMNZS Lachlan being deployed to 'intercept radio activity on Mururoa 1973'. Other historical files related to HMNZS Lachlan are held by Archives New Zealand in Wellington and Auckland. These files are publically available and the reference numbers for each file are enclosed.

It would appear that many of the seamen on this voyage have passed on due to aggressive cancers and considering they were exposed to radiation in the area they showered, washed, drank the water and eat food cooked in it. I am curios to know if any links have been made due to these conditions.

Has the Ministry of Defence opened up to any claims via Veterans Affairs and if so can you outline the structure for claims.

Information and research regarding New Zealand's military veterans who may have been exposed to nuclear radiation is publicly available on the Veterans' Affairs New Zealand (VA) website¹. The website also has information about how veterans' service has been recognised and what additional support or considerations have been made available. This

information concerns Jayforce, Operation Grapple and Mururoa veterans specifically. No evidence has been produced concerning potential exposure for those aboard HMNZS Lachlan.
